





- Structural Dynamics in 2020
 - 42% increase in full-text downloads
 - Impact factor remains high (3.2 in 2019)
 - Slight decrease (-13%) in submissions, publications
 - Slight profit (~\$5,600) due to decrease in spending on marketing and conference travel
- Structural Dynamics in 2021 (Q1)
 - 41% increase in submissions over Q1 2020
 - New Editor-in-Chief George N. Phillips, Jr.
 - Transactions from the 2019 ACA meeting are now online

ACA Revenue


ACA's sources of revenue are limited.

We have taken steps to balance our expenses and income.

- Membership dues remain constant
- Annual Meeting registrations are down 596 (as of 7/31/21) vs 610 in 2020
- Exhibitor booth space and sponsorships at Annual Meeting were holding steady up to 2020
- Different meeting formats were considered for 2021 (inperson, virtual, or hybrid. The hybrid version is the most expensive).





ACA Dues by Year



ACA Membership and Meeting Attendance





Rosenstein bequest

- The trust states that the bequest is "to facilitate the education and training of young scientists", and this is a major goal of the ACA
- Amount: \$250,000.00
- Allocation: \$20,000 is to be spent in 2021 based on the Education Committee recommendations
- The remaining \$230,000 has been invested according to a portfolio designed by the FC. (7/21/21 value: \$238,800).
- The FC recommended for the fund to be dispersed over the next decade to achieve high impact



ACA Membership Initiatives

- Council has been actively working on adopting strategies for increasing/maintaining membership and meeting attendance
- The FC discussed types of membership (no changes)
- Two budgets will be developed for 2021: one with a live meeting and one with a virtual meeting



Finance Committee Initiatives

- FC leadership has been restructured: the CFO Prof. N. Rao's tenure ended; the Treasurer, FC, and ED will be the finance stewards
- Increase ACA FC diversity by inviting younger members to participate. Leighanne C. Gallington (APS) has joined as an observer.
- The ACA Investment Policy Statement has been revised and updated.
- ACA participated in the Small Business Association's Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") loan program in 2020 (\$24,472 loan forgiven) and 2021 (\$20,488)
- Participation in the IUCr 2026 Congress bid



Finance Summary

We were in the red during 2012-2018. The trend was reversed and we have been in the black in 2019 (\$103K) and 2020 (\$256,732K). A profit is projected for 2021 (~\$22,000).

GOAL: to stay cash flow positive; use reserves dividends to rebuild reserves equal to one year's expenses ~\$500,000.

The most important action you can take is Renew your own membership Bring your colleagues and students to ACA meetings Consider adding a small bequest to the ACA in your will
